

# STEALTH HOSPITALITY

## LOYALTY CARD TERMS & CONDITIONS

---

The following terms and conditions govern your membership with and participation in the Stealth Hospitality Loyalty Program (SHLP). Please read them completely and carefully. Stealth Hospitality establishments currently include Mexicano's, King of Snake, The Dirty Land and Chinwag.

### 1.

In consideration of us receiving and accepting your online or written application to become a member of the SHLP, you agree to be bound by these terms and conditions which form a contract between you and us. The terms "we", "us" or "Stealth Hospitality" as used in these terms and conditions refers to Stealth Hospitality and, except to the extent the context does not permit, its various related bodies corporate: including but not limited to Mexicano's, King of Snake, The Dirty Land and Chinwag.

### 2.

SHLP is a membership programme which offers dollar based rewards and, from time to time, specials, bonuses and privileges to the members. To become a member, you must (a) be aged 18 years or over; (b) at [www.stealthhospitality.co.nz](http://www.stealthhospitality.co.nz) ("Website"), complete the online SHLP application form correctly in full with valid information, and then submit that application to us as directed on the Website or fill out SHLP application form in any of our establishments (c) confirm your application by clicking on the link in the email sent from us in response to your application. You only become a member of the SHLP once we accept your application and you receive an SHLP membership card. The acceptance or rejection of an application for SHLP membership is entirely at our discretion.

### 3.

Only those of our employees and their immediate families that are referred to in the relevant Stealth Hospitality staff policy as being eligible for membership, may become members of the SHLP, but are not eligible to participate in any of the Competitions referred to in clause 9 and 10.

### 4.

SHLP membership and benefits are available at all of Stealth Hospitality's establishments. (Refer to clause 1 for list of establishments)

### 5.

The Card at all times remains our property and must be used by you only for the purposes contemplated by these terms and conditions and in the manner directed by us. It is your responsibility to look after the card. In any case where the card is lost or damaged, a replacement card may be distributed at an additional cost of \$10.00 to you.

### 6.

SHLP card is not transferable; we may at any time in our sole discretion ask the bearer of the card for a personal identification to prove the validity of the card.

### 7.

SHLP card is valid only when the cardholder dines in or pays for a takeaway order in one of our restaurants, not valid for home deliveries, out door caterings, special functions conducted in the restaurant without prior consent.

### 8.

As a member of SHLP, you will be rewarded 1 dollar for every 10 dollar spent, in other words 10% of the total amount spent at any Stealth Hospitality restaurants, which will be transferred to your Loyalty card while settling your bill. You may accumulate these reward dollars and redeem them in any of Stealth Hospitality's establishments (Refer to clause 1 for list of establishments) participating in SHLP whenever desired. You need to physically produce the Loyalty card to avail these reward dollars, failing which, reward points pertaining to that particular transaction will be considered void.

### 9

Reward dollars are not redeemable for cash. In the event that any or all of the Stealth Hospitality venues are sold or closed, reward dollars will be considered null and void and there will be no transfer of obligation to the new owners unless they wish to continue the reward program.

### 10.

We may also from time to time make available to members special offers, promotions and competitions, which will be intimated to you either by post or email address provided to us as part of your membership application form.

### 11.

Each promotion and competition will be subject to individual terms and conditions which would be printed on the promotional material or specified on the Website.

### 12.

We may publish names of winners of competition prizes.

### 13.

You agree to receive SHLP emails regarding special offers, promotions and competitions and other SHLP related information.

### 14.

Personal information collected by us is maintained in accordance with our privacy policy set out in the "Privacy Section" on the Website. You agree that any personal information that you provide to us in connection with the SHLP, a voucher or a competition may be used by us for marketing/promotional purposes. When your card is swiped, information such as, without limitation, your frequency of visits, amount spent on each visit, may be recorded and retained by us as part of your member profile. Personal information will only be disclosed to and retained by us for these purposes.

### 15.

We may at any time in our sole discretion, without advance notice, alter or amend these terms and conditions or suspend or terminate the SHLP. Any changes to these terms and conditions will take effect when the Website is updated with the new terms and conditions. Any suspension or termination of the SHLP will take effect on the first to occur of notification to you by email (or any other method of notification considered appropriate by us) or posting on the Website.

### 16.

We may at any time in our sole discretion terminate your SHLP membership with immediate effect by giving notice to you by way of email or any other method of notification considered appropriate by us. On termination of the SHLP or your SHLP membership or at any other time requested by us, you must immediately destroy or return the Loyalty card to the one of the Stealth Hospitality establishments (Refer to clause 1 for list of establishments) directed by us.
